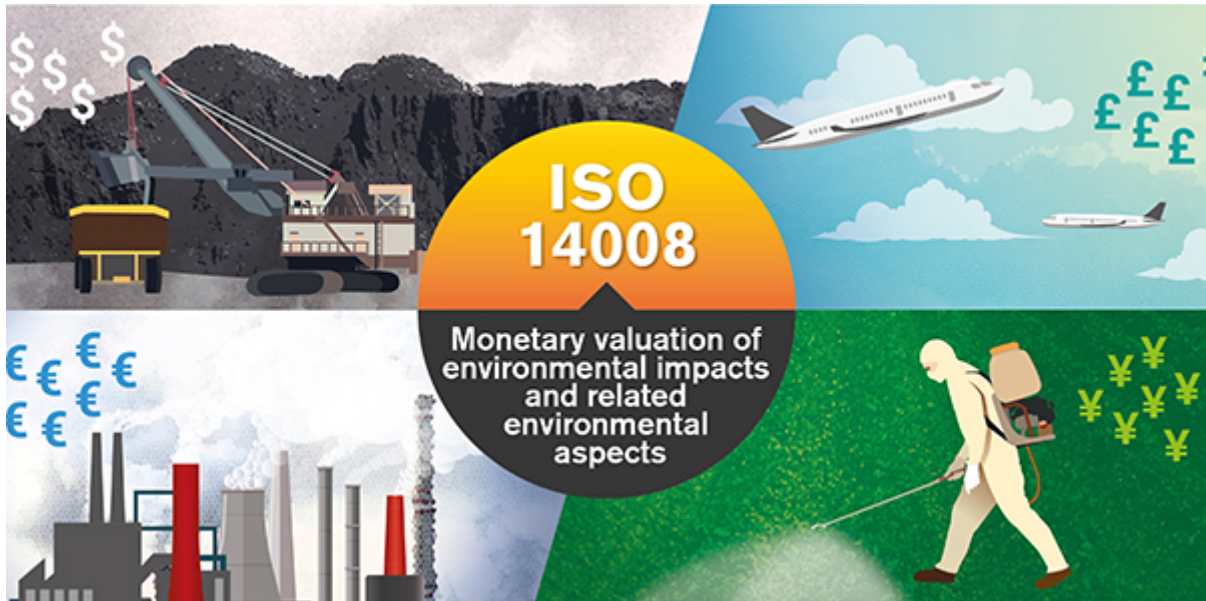

New global standard counts the cost of environmental damage

Environmental damage costs society enormous amounts of money – and often leaves future generations to foot the bill. Now, a new ISO standard will help companies value and manage their environmental damage, by providing a clear framework for estimating the cost of their impacts on the environment. The standard is a result of an initiative within the Swedish Life Cycle Center. The standard was launched in March and the full name is ISO 14008 – Monetary valuation of environmental impacts and related environmental aspects is the name of the standard, launched in March 2019.

On May 28, the standard will be presented in a seminar arranged by Swedish life Cycle Center NMC and SIS.

How to use the Product and Organisation Environmental Footprint methods in policies?

“A company wishing to market its product as environmentally friendly in several Member State markets faces a confusing range of choices of methods and initiatives. Sometimes they have to use different ones for different markets. This results in costs for companies and confusion for consumers. The European Commission proposed the Product Environmental Footprint and Organisation Environmental Footprint methods as a common way of measuring environmental performance. The approach was tested between 2013-2018 together with more than 280 volunteering companies and organisations. The results and reports of the pilot phase are available.

Based on the results of the testing, the European Commission is now exploring how to use the Product and Organisation Environmental Footprint methods in policies", in a transition phase. (European Commission, 2019)
